Sir /

Mr Creech has written about some debt due, & I am desirous of writing you on the subject and hope you will excuse my doing so. - I had told Mr Creech that I could not possibly pay more than 500 £ for the two years if I was compelled to stay on the 2 years and which I could not present because my notice then was always too late till this year. I am writing to have the matter settled up at once if you would consent, for one reason that I am

satisfied the getting away, and
