Dear General Pitt-Rivers

Mr Creech writes that you wish to register your Title to all your estates and asks if it will be an expensive proceeding -

The Registry make a very great point of identity - your estates are very large and the main title consists of the bills of the first & second Lord Rivers and of the Act of Parliament - None of these documents contain any description of the estates they deal with, beyond general words which are of no service for the purpose of identification.

Hence there will be a great deal of trouble in satisfying the Registry Officials and the expense will be very heavy -

If you were intending to sell your estates in Smallish Lots it might be worth your while to register your Title otherwise I do not see that you will gain any commensurate advantage by registering -

Pray do not think I have any general objection to registering Titles - I only don't see the point of it in your case - a case in which I know the expenses must be unusually heavy -

Probably we should have to go back for 100 years to find a detailed description of the bulk of your property & when we had found it lapse of time would most likely have made such description inapplicable
