  - "At all elections for the offices of Physician and Surgeon the votes of Governors shall be taken by signed Polling Papers, and delivered at a General Meeting to the Chairman by some Governor present, not later than one hour after the chair has been taken. In the event of only one Candidate for a vacancy on the Honorary Medical Staff, the Governors shall vote for or against such Candidate. Governors may vote by letter, but must affix 1d. stamp, in accordance with the Stamp Act, otherwise their votes will be void."

## RULES

For Honorary Surgeon-Dentist.

1.—The Qualifications of the Surgeon-Dentist shall be a Licentiate in Dental Surgery of the Royal College of Surgeons of England, Edinburgh, or Ireland.

2.—The Surgeon-Dentist will be required to attend at the Hospital on Wednesdays and Saturdays, from 12 to 1 p.m., and in cases of emergency, when so notified by the House Surgeon.

3.—His duties will be: the treatment of diseases peculiar to the teeth, and will include amalgum fillings, and extraction. He will also assist the Surgeons, when requested, in all cases of injury to, or disease of the jaws, including the making of splints.

4.—When Dental cases are admitted as In-patients they shall be under the Surgeon of the week, who will act in conjunction with the Surgeon-Dentist.

5.—The House-Surgeon will act under the direction of the Surgeon-Dentist in the treatment of Dental cases.

6.—Except in the case of simple extraction, Dental patients shall be seen only on the production of an Out-patient's ticket.

7.—The Surgeon-Dentist or House-Surgeon shall enter in a book, kept for the purpose, the names of all Dental patients; and this book, together with any recommendations which have been sent in, shall be laid before the Weekly Board.
